Temporary Recognition has been granted to classes VI to X (E.M.) in respect of Vignan High School, L.I.C. Colony, Guntur upto the year 2013-2014 in the orders 1st read above. The Deputy Educational Officer, Guntur has recommended for grant of Extension of Temporary Recognition to classes VI to X (E.M) without aid from 2014-15 to 2023-2024 vide letter 3rd read above, the District Educational Officer, Guntur has verified the application for grant of Extension of Temporary Recognition with reference to the Inspection Report of the Inspecting Officer and also with the reference to the conditions laid down in the permission orders and G.O. Ms. No.1 Edn., (PS-I) Rules Department, Dt:01-01-1994 and G.O. Ms. No. 41 Edn., Dt. 11-05-2006 and submit a report in his letter 4th read above.

After Careful examination of the references read above and the conditions prescribed in G.O. Ms. No.1 Edn., Dt:01-01-1994 and G.O. Ms. No. 41 Edn., Dt.11-05-2006 the Regional Joint Director of School Education, Guntur here by accords for grant of Extension of Temporary Recognition for a period of 10 years from 2014-15 to 2023-2024 for classes VI to X (E.M) without aid in respect of Vignan High School, L.I.C. Colony, Guntur with aid now or in future. However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abide by the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the Institution shall adopt the curriculum and syllabus prescribed from time to time by the Government of the Andhra Pradesh.
4. The school timings, vacation and mid-term holidays shall be followed as prescribed by the Govt. from time to time.
5. That the qualified staff with in the age limits as prescribed by the Govt., for Government Employees, shall be appointed as per the Staffing pattern.
6. That the results of the Institutions shall be satisfactory every year.
7. That the records \accounts shall be furnished to the D.E.O every year.

8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.O.s and other orders which are not specified in these orders shall be complied with.
11. That the school shall not be closed without giving notice both to the Parents / D.E.O and competent authority at least 6 months before.
12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of state level Inspection and vigilance committee fulfilling of all the pre-requisite conditions under the A.P.Edn, Act 1982 and if later found that, the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.
15. The Management is requested to submit Final No Objection Certificate form the Fire and Emergency Services Department within 3 months.
16. The Management is requested to fulfill conditions stipulated in G.O. 9th read above within 3 months and submit compliance.
17. The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit this office through the Deputy Educational Officer, Guntur and District Educational Officer, Guntur District every year.

Further, the managing committee of the school is requested to fulfill the above requirements to cope up with the needs of the institution at the latest before submission of application for extension of Temporary Recognition for the year 2024-2025.

This has the approval of the Regional Joint Director of School Education, Guntur.
